 - B. Siemens Aktiengesellschaft: A discussion was had, and by motion (Bronner, seconded by Rupnik) the board voted to accept the appeal and certification that Siemens Aktiengesellschaft, and Siemens qualifying entities be removed from the list of Prohibited Entities (6-0-0).

- 7. Other Business: A discussion was had about reconciling the prohibited entities lists and clean up from the website migration. Additionally, Mehta updated the Board on vendor updates for the Migrant Shelter list and Russian and Belarus Bill.
